Greenhouse Fund GP was the beneficial owner of 3,920,961 shares of Common Stock in its capacity as general partner of certain private funds advised by Greenhouse, including: (i) Greenhouse Master Fund, which was the beneficial owner of 1,997,839 shares of Common Stock and (ii) Greenhouse Long Only Master Fund, which was the beneficial owner of 1,923,122 shares of Common Stock.
